The Texas VHF-FM Society will hold their annual board of directors election at the Society's general meeting on August 5th at the Austin Summerfest in Austin, TX. Summerfest takes place August 4th and 5th at the Red Lion Hotel, also known as the Holiday Inn Crowne Plaza located at Interstate 35 and US 290, Exit 238-A, 6121 North Interstate 35. The Texas VHF-FM Society is about to enter its 42nd year and is the ARRL recognized frequency coordinating body for the State of Texas. This non profit organization is responsible for 50 MHz and higher frequency coordination and for promoting efficient amateur radio spectrum use statewide.

There are 9 seats on the board and each member sits for a term of 2 years. In even years, 4 seats are up for election while in odd years, 5 seats are considered. The election will be held during the general meeting and all Society Members, excluding Vested, Associate and Affiliated Group Members, may vote. The Society will have a table set up at Summerfest both Friday and Saturday, where amateurs may join, renew or otherwise verify their membership status.

Nominations are still being accepted and you may nominate yourself. Thankfully that is over and gone, and the next two years can be spent working on problems that will have happy solutions. The "voting rights" act coming up at the summer meeting will be a watershed policy change for the Society. We will have more members voting on issues, and the Society will need to work very hard to provide information on all sides of the issues, so that the membership who choose (for whatever legitmate reason) not to journey to the general meetings to have a voice in the operations of the Society.

I look forward to another two years of advancing ham radio in the State of Texas.

presently publicist of the association.



- Full-sized tables: 6 feet by 30 inches. \$10 each, limit of 3 to a customer. First come, first served.
- 2. AC power is available at an additional \$5 per customer, through advance registration only.
- We'll attempt to honor requests from groups of sellers for adjacent tables, if we receive your registrations in the same envelope.
- If you advance register for swap tables, we'll attempt to notify
 you in advance if they are unavailable due to being sold out
 (a rare occurrence). Be sure to give us your email address if
 you have one so we can notify you that way.
- 5. Your table(s) will be held for you until 10 am Saturday.
- Swapfest hours are 6 to 9 pm Friday and 8 am to 1 pm Saturday. Opening times are for both sellers (for setup) and shoppers.
- 7. Buyers and sellers must be registered at the convention.
- 8. And then there's our Tailgate Swap Area. If you have something huge to trade--or just want to worship the sun--try our tailgate swap area outside the hotel; first come, first served. As an outside swapper, you don't need to be registered at the Convention, but of course you'll want to, so you can visit with the indoor swappers and attend the sessions.
